Rules and Regulations

1. This contest shall be known as the NJBBA Surf Fishing Contest. There is no entry or registration fee; however; only paid up members of the NJBBA may participate.
2. All fish must be caught by hook and line/rod and reel between March 1 and December 31 from the surf, bay shore, pier or jetties in New Jersey waters (no boats)
3. Species included are Northern Kingfish, Bluefish, Striped Bass, Weak Fish and Fluke.
4. There will be a 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> prize in each category, with \$50 for 1<sup>st</sup>, \$30 for 2<sup>nd</sup> and \$15 for 3<sup>rd</sup>. No participant may win more than one prize for each category. Prizes will be awarded at the Annual Banquet.
5. Only this Affidavit or an exact facsimile will be accepted and must be postmarked within 5 days of the date the fish was caught. The affidavit must be filled out completely and if not may be cause for disqualification.
6. Fish must be measured at any bait and tackle shop in the state of New Jersey. Fish are to be measured from the tip of the nose to the tail. It will be permitted to squeeze the tail of a Striped Bass
7. Winners will be determined by length and in the event of a tie by girth.
8. NJBBA Board of Directors reserves the right to modify this tournament or rules should the circumstances arise. The decision of the Officers and Board of Directors will be final.
